 - b) for purposes related to the participation of the Journalist at the infoShare 2019 Conference in accordance with "Media Registration Terms" (hereinafter: Terms), pursuant to Art. 6(1)(b) of the GDPR.
- 4) Your data will not be disclosed to Recipients. It can however be processed by Processors i.e. entities the Controller will be cooperating with in order to realize the project infoShare 2019 Conference.
- 5) a) for purposes of conducting the process of selecting Speakers for the infoShare 2019 Conference in accordance with Art. 6(1)(a) GDPR,
- b) for purposes related to the participation of the Journalist at the infoShare 2019 Conference in accordance with "Media Registration Terms" (hereinafter: Terms), pursuant to Art. 6(1)(b) of the GDPR. Your data will be stored from the moment your consent is granted, during the period of cooperation in accordance with the Media Registration Terms and for the time necessary for the performance of tasks connected with the Terms. Your data will be stored thereafter for a period corresponding to Terms related claims' limitation period or for as long as a legal obligation exists regarding storing accounting and financial documentation.
- 6) You have the right to access your data, rectify them, delete them, limit or oppose their processing, their portability and the right to lodge an objection against the processing of your data by the Controller.
